- x Identified as having difficulty paying their tuition and fees and at risk of being dropped from their Spring 21 course on 2/15 and
- x Have a valid 2020-2021 SIR on file with the University and determined to be meeting general Title IV eligibility requirements and
- x Have an Emergency Aid Application on file, completed on or after January 22, 2021

Group 2 (\$400-\$2000)

- x Students who were identified as having a remaining unmet need greater than \$720 and
- x Enrolled in the Spring 21 semester and
- x Have a valid 2020-2021 SIR on file with the University and determined to be meeting general Title IV eligibility requirements and
- x Have an Emergency Aid Application on file, completed on or after January 22, 2021

Students had until March 7, 2021 to apply. The award amount for group two was based on the needs identified by the student on their Emergency Aid Application and the funding model below:

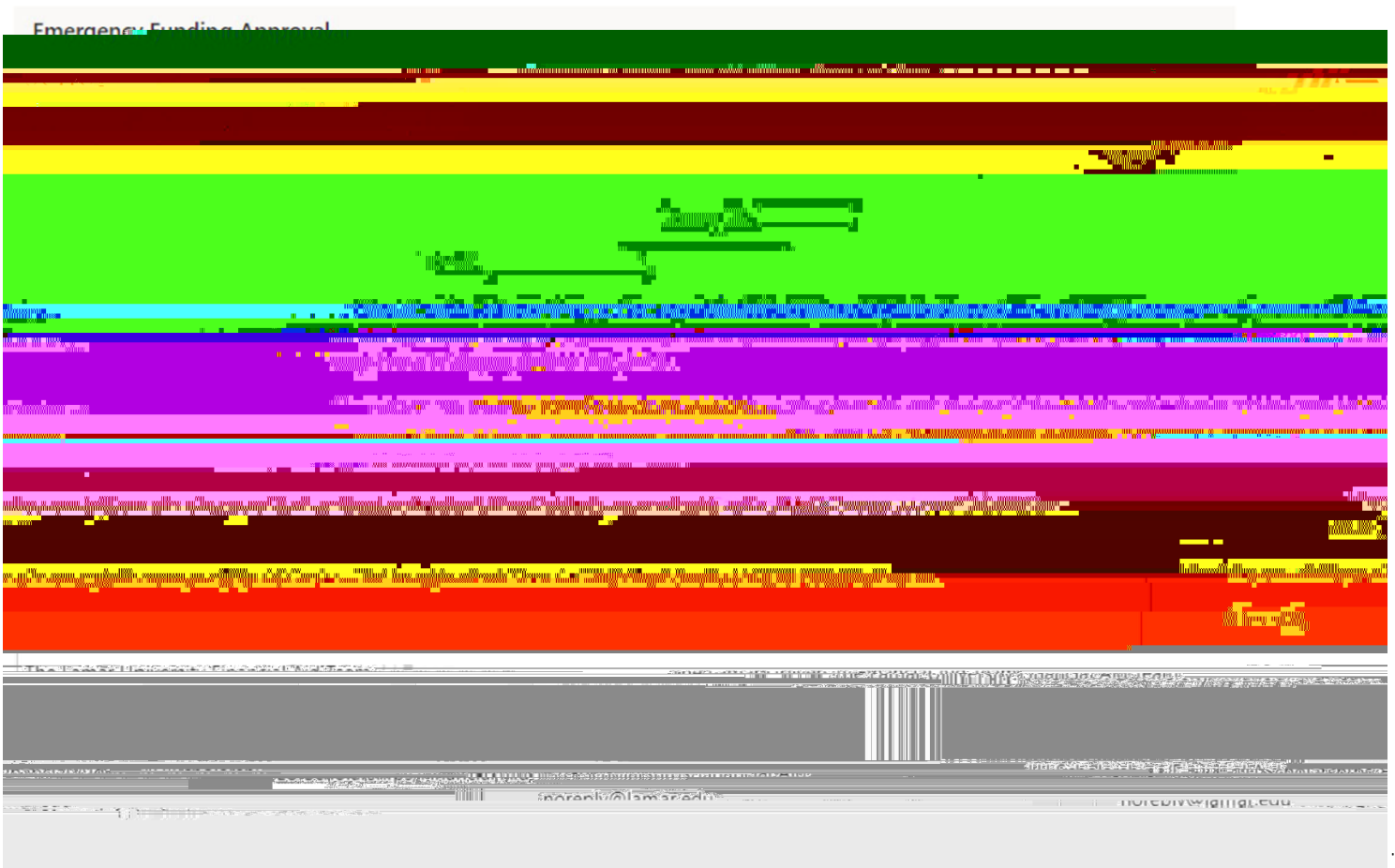
